

# USRC Triples 2016 Rule & Fixture

1. The competition shall be conducted in accordance with the “Laws of the Sport of Bowls, Crystal Mark Third Edition” of World Bowls.
2. Match date and time is to be achieved by mutual agreement between players. Matches shall be completed on or before the stated completion date of each round. The Subcommittee reserves the right to appoint match date and time if players fail to agree on match arrangement.

### 3. Venue

- All first round matches, matches of Losers Bracket and the Final will be held at USRC. Team of left-handed side shall make rink arrangement with Green Convenor at least 2 days before the match.
- Matches of Winners Bracket will be at public greens. Team of left-handed side shall be responsible to make rink reservation. Fee for 3-hours rink booking will be reimbursed by LBS after completion of each match.

### 4. Substitution

- One substitute is permitted for each team in each match. No substitute shall play in the position of skip.
- Bowler is allowed to substitute for more than one team.
- Substitute will not become permanent member of the team regardless of number of appearance.

5. Condition of Play

- Two bowls Triples.
  - Each match will consist of 2 sets; each set played over 7 ends. A set is decided when a team is unable to win or draw in the ends left. The winner of the match being the best of two sets. If the match is tied (two drawn sets or one set each), a tie-break consisting of 3 ends will be played. The winner of the tie-breaker will be the team with the highest number of shots when the third end is completed. If at the completion of the third end of the tie-break the scores are equal a fourth end will be played, and so on and so forth.
  - Trial end with two bowls in each direction is allowed before the start of play in any game or before continuing an unfinished game.
  - No visit to head.
  - No dead ends. A jack goes out of bounds will be re-spotted on the centre line with the nearest point of the jack to the mat line at a spot which is 2 metres from the front ditch, commonly known as the “T”.
